RURAL FIRE SUBSCRIPTION PROGRAM TERMS AND CONDITIONS

Annual Dues:

The term of the fire subscription shall be from January 1 until December 31 of each year. The annual dues shall be \$75.00 for primary residence and any attached property or acreage. The Subscriber may also cover any other properties or separate acreage at an additional fee of \$40.00, which shall cover all properties and acreage owned by the subscriber, whether attached to the primary residence or not. Any land or property, which is leased to another individual, shall not apply.

Annual dues or billing benefits shall not be raised by the Town of Glencoe during the time the subscription is in effect, and 15-day notice shall be given to the subscriber in the event any existing rates need to be adjusted.

Benefits:

Any property owner holding a valid subscription with the Glencoe Volunteer Fire Department shall not receive any additional bills, in the event of a response to a reported fire by the Glencoe Volunteer Fire Department.

Exclusions:

1. The Glencoe Volunteer Fire Department will not conduct controlled burning for the property owner at the reduced rate of this subscription program.
2. In the event the Glencoe Volunteer Fire Department is unable to respond, the Fire Department or the Town of Glencoe shall not be held liable or responsible in any manner for damage sustained due to fire, or for any billing fees submitted by another fire department responding in the absence of the Glencoe Volunteer Fire Department.
3. Any property owned by one individual, but leased to another individual, shall be considered separate ownership, and require a subscription by the lease.
4. Any property owned by one individual, with multiple residences will require a subscription per residence.
5. All property covered under this subscription must be located within the Glencoe Fire District boundary, or within an 8-mile radius of the Glencoe City Limits.
